OFFICE MEMORANDUM

Imphal, the 15th June, 2013

No.3/1/Misc./2008-Com(Rev)Pt : The decision of the State Government relating to computerization of land records in all the 4 (four) valley districts and the transfer of land records from the Directorate of Settlement and Land Records to the concerned Deputy Commissioners as notified vide this Government's Office Memorandum of even number dated 24-03-2013 has been reviewed by the State Government and it has been decided as follows :

- (i) Directorate of Settlement & Land Records, Manipur shall complete transfer of all available land records of 4 (four) valley districts to the concerned Deputy Commissioners of Imphal West, Imphal East, Thoubal and Bishnupur districts and the Deputy Commissioner, Bishnupur shall transfer the land records of Churachandpur District to Deputy Commissioner, Churachandpur District within 30th June, 2013. If any land records of Churachandpur District are still with Additional Deputy Commissioner, Jiribam, those shall be also transferred by Deputy Commissioner, Imphal East / ADC, Jiribam to Deputy Commissioner, Churachandpur within 30th June, 2013. The land records of three sub-divisions viz. Kangpokpi, Saikul and Saitu Gamphajol shall be transferred to ADC / Kangpokpi within 30th June, 2013.
- (ii) Computerization of all land records shall be completed by 31st March, 2014. The Revenue Department and the Directorate of Settlement & Land Records, shall with the assistance of NIC / DIT, Manipur extend full co-operation to enable the Deputy Commissioners to complete the computerization by 31st March, 2014.

2. Director, Settlement & Land Records, Manipur, Deputy Commissioners of Imphal East, Imphal West, Thoubal and Bishnupur districts and Additional Deputy Commissioner, Jiribam are therefore, directed to strictly comply with the above Government decision.
