Issues & Decision.

1. **Non-uniformity in entry of data in Dag No.**

It is observed during computerisation of the land records in Imphal East District that there is an ambiguity in recording of Dag No. as and when a new Dag comes up in excess of the limit of 1000 (One thousand) Dags per Sheet. In some areas, the additional Dag number in excess of 1000 is identified by suffixing 'A' to the Dag No., while in some other areas, the additional Dag number in excess of 1000 is sequentially named as 1001, 1002 & so on in the same sheet number.

The matter was discussed. It was pointed out that the sequential naming in order of 1001, 1002 & so in the same sheet number on would be more convenient to the public & Offices.

It is, therefore, decided that the sequential nomenclature of Dag number in excess of 1000 as 1001, 1002 & so on in the same sheet number would be followed for Imphal East District.

The District Information Officer/NIC, Imphal East will work out the technical details accordingly.

2. **Recording of status of land on Jamabandi/Dag Chitha/ROR.**

It was pointed out that if the status of land regarding mortgage caveat/objection etc. is recorded on the Jamabandi/Dag Chitha/ROR, it would reduce cases of forgery, sale of mortgaged land to unsuspecting buyers etc. Hence, it is decided that the status of land regarding its mortgage, caveat/objections/etc, if any, shall be recorded in the remarks portion of the Jamabandi/Dag Chitha/ROR.
